



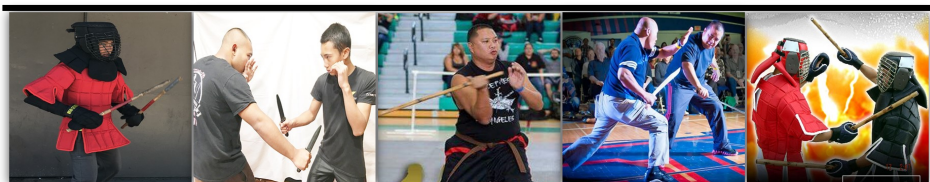

## 2017 OC OPEN MARTIAL ARTS TOURNAMENT—STICK & KNIFE FIGHTING

**General Information and Rules**

The organizer reserves the right to reject and not accept tournament registration for participation based on a competitor's or organization's previously known participation record/behavior.

We encourage everyone to cooperate and help to make this a memorable, dignified and prestigious event.

**Check-in.** All participants must check in at the tournament by 9:00am. Failure to appear after a 30-min. grace period will result in automatic disqualification/loss.

**Weigh-in.** There will be a random weigh-in the day of the tournament. Participants must put their weight and height on the registration form.

**Tournament Directors.** Executive Tournament Director is Grand Master Felix Roiles. Assistant Tournament Directors will be selected from a representative of participating schools and organizations.

**Judges.** There will be three judges per ring. All judges have undergone training and orientation on the rules and procedures of the tournament. The selected and pre-certified judges are trained in Weapons and Unarmed Combat.

**Referees.** All referees are veteran martial artists and have undergone training and orientation on the rules and procedures of the tournament.

**Time and Score Keepers.** Non- participating and volunteer members of local organizations will alternate in these roles.

**Mandatory Equipment.** Headgear, gloves, arm/knee/elbow pads, groin protector, and mouthpiece.

**Weapons / Sticks.** Will be provided.

**Dress Code.** All participants must come in: Proper school/organization uniform, sweat pants and t-shirts must display school logos, no jeans, rubber shoes area mandatory. Inappropriate outfit is not be allowed.

**Rules: The organizers reserve the right to modify the rules to preserve the safety of the participants.**

**Time Period.** A match is three 1-Minute (60 Second) rounds, with two 30-second rest periods between each round. Each round and rest period is monitored by the time keeper.

**Primary Targets.** Top, Front and Sides of the head/headgear; Front and Side of the Thighs and Body; Both Arms and Hands; Back of the Body and Headgear are legitimate targets when facing each other.

**Not Allowed.** No Punching, Kicking, Kneeing and use of elbow; Grappling or Wrestling; Trusting; Throwing; Foot sweeps; Strike to the back when opponent is not facing; Locking and Holding; Use of foul or abusive language; pitting.

**Jamming.** Jamming with the free hand is allowed. Jamming is defined as controlling by intercepting the opponents weapon or hand. However, any interception that comes in contact with the opponent's weapon will be considered a hit.

**Disarms.** Disarms must be immediate, or have immediate release. Joints may not be locked or twisted for disarm. 1-2 disarms shall be scored as part of the match. 3 disarms will result in a TKO.

**Broken Weapon.** During contact, a break in weapon during contact is considered a disarm.

**Loss of Weapon/Grip.** During attack or counter attack, loss of weapon and grip is considered as disarm. The Referee must call attention of Judges for the score/award.

**Scoring: Is based on the total combination of Technique; Power; Accuracy; Defense; Offense; Aggressiveness, and Over all Ring Performance.**

**Scoring.** All matches will be scored by three Judges using the Ten Point must system.

**Ten Point Must System.** Even Round = 10-10; Slight Edge = 10-9; Wide Edge = 10-8; One Sided = 10-7  
 Out-of- bounds. Participants must remain within the boundaries of the designated ring. Repeated out of bounds will result in a point deduction.

The Referee will monitor the general progress of the match and determine the observation and adherence to the rules, the legitimacy of disarming techniques and all point deductions for any foul action or behavior.

**Fouls.** For each foul, the referee may progressively issue a/an Casual Warning; Official Warning (notify judges); Point Deduction (notify Judges); Final Warning; Disqualification.

For any blatant, malicious and dangerous offense, the Referee can and should immediately issue a Final Warning or Disqualification.

Note: Fighters / Participants are restricted at Officials tables. We encourage every school and organization to have representatives.
